A Message from the President

In a recent opinion article featured in the Erie-Times News, Bob Bertolette of LeadingAge PA stated, "Hospital care during COVID-19 makes headlines, but nursing homes cannot be forgotten."

It's true – as the larger community begins to return to pre-pandemic routines, we hope they won't forget that long-term care communities continue to face funding and resource challenges while residents, families and employees are still feeling the pressure of the pandemic. Universal masking, testing, isolation and quarantine, social distancing are all still parts of our vocabulary and daily experience.

On February 28th, an employee COVID-19 vaccine mandate went into effect as directed by the Centers for Medicare and Medicaid Services in order to continue to receive funding. All employees at Saint Mary's who were not fully vaccinated by that date were considered to have voluntarily terminated their employment. In the end, about 10% of our staff parted ways. Vaccination is vital to safeguarding the health of our community. We hope vaccination continues to be taken seriously even as we get back to "normal."

Last summer, the Pennsylvania Department of Health announced upcoming efforts to increase the minimum number of direct care hours for residents from 2.7 to 4.1 hours per day. While finding ways to improve patient care and quality of life is welcome, this proposal offers no new funding and is once again asking nursing homes to do more with less resources. It's also no secret that there is a workforce challenge. Drive down any business strip and you'll likely see "We're hiring!" signs – maybe you've even seen ours outside of Asbury Ridge.

In response to challenges like these, we're strategizing. We're focusing our energies and resources on optimizing operations and researching alternate funding sources. In July of 2021 we implemented a wage increase across the board for all employees and we doubled our referral bonus for employees who bring in new talent. We put ourselves through a voluntary but rigorous Infection Control Assessment and Training survey conducted by The Association for Professionals in Infection Control and Epidemiology (APIC) and Saint Mary's is entering our fourth year as a CARF-CCRC Accredited facility – all of which is part of our relentless pursuit of quality.

We will continue to ensure our strategic vision is as robust and resilient as our people have proven themselves to be. We are hopeful that we're turning a corner in the pandemic and that legislators will take action that shows they value older Americans. We will not let our residents, families, and employees be forgotten.

New & Improved

\$61,000 grant provides funding for capital improvements

As a nonprofit nursing home, Saint Mary's relies on the generosity of donors to help fund our mission. Saint Mary's Home of Erie is fortunate to receive support from individuals, families, community organizations, foundations and grants.

At the end of 2021, Saint Mary's received a \$61,000 grant from the Spaeder/Saint Mary's Home Fund of the Erie Community Foundation. This fund, established by John A. and Margaret E. Spaeder, was designed to aid Saint Mary's in our capital improvement projects and assist with operating expenses. Since 2011, Saint Mary's has received over a half a million dollars from this fund and has used that money to help with expenses related to furniture replacement, an Activities van, a wheelchair accessible mobility van for resident transportation, the replacement of a snow plow truck, a new resident bathtub, overbed skilled nursing tables, and automated external defibrillators – to name a few. Here are a few ways the most recent contribution is making an impact!

Medical Equipment

Saint Mary's was able to purchase six new Digital Blood Pressure Monitors with stands as well as six handheld pulse oximeters. The ability to have digital blood pressure readings helps our nursing team improve care and relieves some of the burden of transporting devices as the new stands are on wheels. "Our new equipment has allowed the staff to obtain vital signs more quickly and more accurately, thus providing better and more efficient overall resident care", stated Sarah Luce, Nursing Unit Supervisor for Neighborhood D.

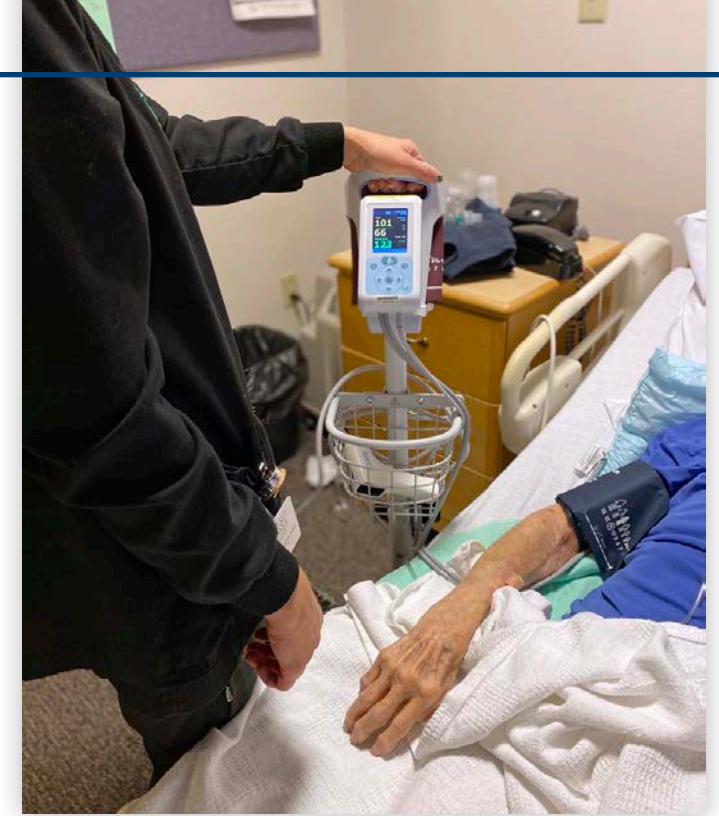
Additionally, some of our rock-n-go wheelchairs received new cushioned supports. The new cushions will ensure these chairs continue to be comfortable for our residents while offering needed support. These chairs also tend to look more like furniture than a traditional wheelchair which helps to promote dignity while the rocking motion is calming.



Lifestyle Improvements

All 80 of our Skilled Nursing rooms are being upgraded to a new wall-mount system for our provided televisions. The wall mounts allow for more space in the resident rooms and will make the resident's viewing experience much more comfortable.

Uht Hall, our multipurpose room that serves as the location for Residential Living Activities, received new sun shade window treatments. The previous window shades did not provide full coverage of the windows and often resulted in sunlight streaming directly onto resident faces while they were trying to enjoy a game or watch a movie.

Enhancing the Dining Experience

Our kitchen is centrally located to equally serve the Skilled Nursing and Residential Living residents, which means food has to be transported to the units. The Dietary Department was able to benefit through the purchase of two new dietary transport carts. These carts help to keep prepared food protected and at the desired temperature while being moved from the kitchen to the dining rooms on our units. We know how important a hot meal is!

Saint Mary's is grateful to be a recipient of this grant and is grateful for the confidence of the Spaeder's as well as all those who manage this fund. Grants such as this make it possible for Saint Mary's to continue to enhance the quality of life for seniors!

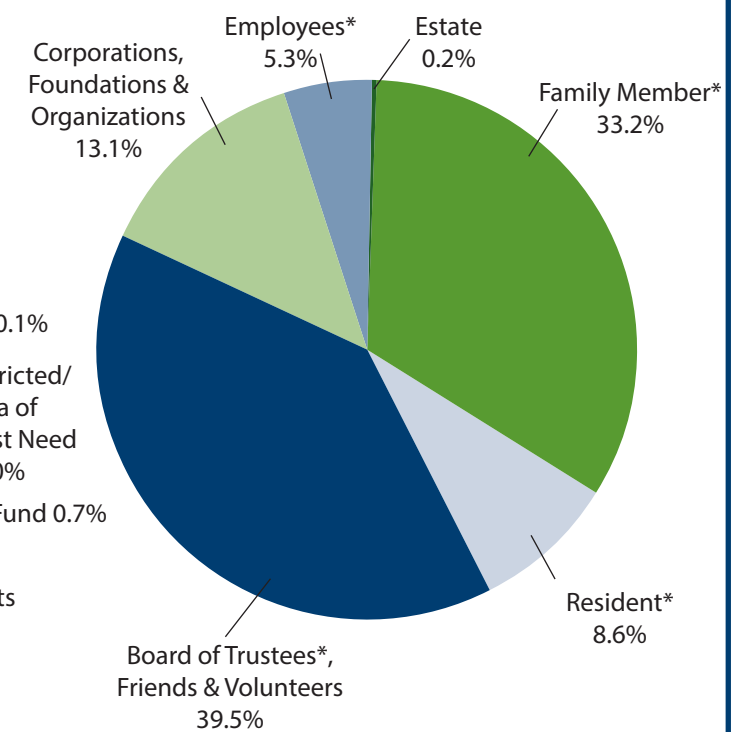

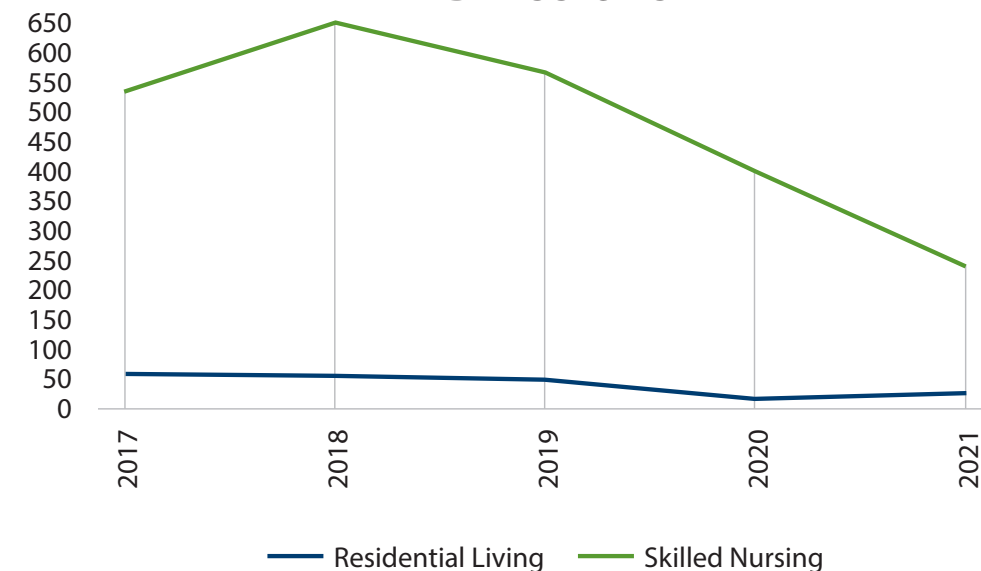
OPERATING EXPENSES
