Robert Orton Named Next President & CEO of Saint Mary's Home of Erie

The Board of Trustees for Saint Mary's Home of Erie and the Leadership of the Sisters of St. Joseph of Northwestern Pennsylvania have named Robert Orton as the next President & CEO of Saint Mary's effective July 1, 2024.

Orton brings more than 20 years of leadership experience to the role, including from his current position as Vice President for Operations at Saint Mary's. He began his career at Saint Mary's in 2000 working as a Maintenance Supervisor until 2004 when he was promoted to Director of Support Services. As Director, he oversaw the Maintenance, Housekeeping, Laundry and Groundskeeping departments. He held that position for over a decade until achieving another promotion in 2020 when he was appointed as Vice President of Operations.

As Vice President, Orton continued to streamline and improve facility operations and services. Most recently he oversaw the multi-year construction project to expand the Carriage Homes at Asbury Ridge. He also oversaw the Residential Living and Personal Care renovations converting eight studio apartments to four two-bedroom suites. Throughout the COVID-19 pandemic, Orton led the team response while establishing policies and processes for navigating forward.

His extensive knowledge of both Saint Mary's and the industry, along with a strong work ethic and firm commitment to always doing what is best for the residents and employees, make him well qualified to step into the role.





JOHN C. REILLY, M.D. Retired Surgeon

Get to Know Father Vincent

A look into the life of Saint Mary's newest Chaplain

Father Vincent Cieslewicz joined Saint Mary's at Asbury Ridge as Chaplain in July of 2023 after the retirement of Father William Fischer.

As a child, Father Vince felt drawn to religious life but he did not begin down the path to priesthood right out of school. Father Vince first met the love of his life, Wendy, and they married as a young couple in the Polish National Catholic Church (PNCC) of which she was a member. Father Vince served as a Deacon for some time in the PNCC until responding to a higher calling to enter the priesthood. The Polish National Catholic Church, which is an independent Old Catholic Church with origins in Scranton, PA, allows priests to marry.

In 1994, just one week before his 20th wedding anniversary, Father Vincent became an ordained priest. He ministered for over a decade until the mid-2000's, when a group of PNCC clergy members approached Pope John Paul II asking to join the Roman Catholic Church. Pope John Paul II granted this request.

Prior to his assignment at Saint Mary's at Asbury Ridge, Father Vince was assigned by Bishop Donald Trautman, of the Roman Catholic Diocese of Erie, to St. Elizabeth of



Hungary Parish in Smethport and St. Joseph in Mt. Jewett where he ministered for 18 years. He also served as Catholic Chaplain at the federal prison, FCI-McKean, in McKean County for 15 years.

"My biggest priority at Saint Mary's is to continue the traditions of the priests before me," Fr. Vince expressed. "Everyone has been so welcoming, and it has been a pleasure to get to know the residents and staff."




